

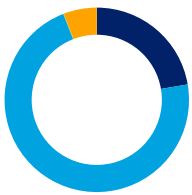

## EOS at Federated Hermes

Over the last quarter we made voting recommendations at **860** meetings (**12,347** resolutions). At **617** meetings we recommended opposing one or more resolutions. We recommended voting with management by exception at **50** meetings and abstaining at **one** meeting. We supported management on all resolutions at the remaining **192** meetings.

### Global

We made voting recommendations at **860** meetings (**12,347** resolutions) over the last quarter.

### Developed Asia

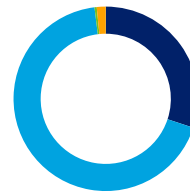
We made voting recommendations at **151** meetings (**1,828** resolutions) over the last quarter.

### Emerging and Frontier Markets

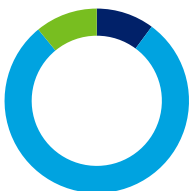
We made voting recommendations at **256** meetings (**3,353** resolutions) over the last quarter.

### Europe

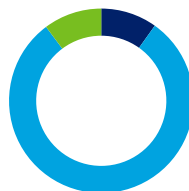
We made voting recommendations at **128** meetings (**2,622** resolutions) over the last quarter.

We made voting recommendations at **38** meetings (**835** resolutions) over the last quarter.

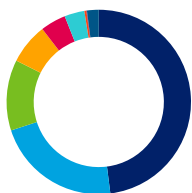

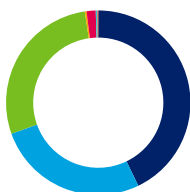
