Over the last quarter we made voting recommendations at 526 meetings (3,635 resolutions). At 283 meetings we recommended opposing one or more resolutions. We recommended voting with management by exception at four meetings and abstaining at one meeting. We supported management on all resolutions at the remaining 238 meetings.

Global

We made voting recommendations at 526 meetings (3,635 resolutions) over the last quarter.

- Meetings against (or against AND abstain) 53.8%
- Meetings abstained 0.2%
- Meetings with management by exception 0.8%

Australia & New Zealand

We made voting recommendations at two meetings (10 resolutions) over the last quarter.

We made voting recommendations at 17 meetings (243 resolutions) over the last quarter.

We made voting recommendations at 14 meetings (199 resolutions) over the last quarter.

- Meetings against (or against AND abstain) 78.6%
- Meetings with management by exception 14.3%

United Kingdom

We made voting recommendations at eight meetings (173 resolutions) over the last quarter.
